**Question #1:** *Please define “marked” versus “unmarked”? There is no definition.*

Answer: The difference in the two are the specifications. Some examples are, Marked will have rubber flooring, white in color and steel wheels. Unmarked will have carpet flooring, aluminium wheels and color to be chosen at time of order.

**Question #2:** *On the 2WD “Marked” Full-Sized Sport Utility Vehicles: Does this vehicle need to be Police Speed Rated?*

Answer: Yes.

**Question #3:** *On the 2WD “Unmarked” Full-Sized Sport Utility Vehicles; Does this vehicle need to be Police Speed Rated?*

Answer: Yes. SSV will do provided it meets all the listed specifications.


