To All Prospective Proposers,

The following information is being provided to aid in preparation of your proposal submittal(s):

Question #1: *Are there any drawings showing the sizes of the areas for the playground equipment? Or can you tell me what are the dimensions for the two areas? What kind of border will you be using, plastic or concrete?*

Response: There is a pre-existing concrete border. As far as the dimensions and shapes it is up to the vendor to make an onsite assessment so as not to have any discrepancies in the areas.

Question #2: *Please confirm that no payment or performance bond will be needed.*

Response: There are no payment or performance bonds required for this RFP.

Question #3: *Please confirm that all existing equipment will be removed by the county and no site work before install will be needed by us.*

Response: The County will have all existing equipment removed.

Question #4: *When work is complete you will desire 9" or 12" of EWF to be existing?*

Response: That will depend on the height of the proposed play structure being installed.

Question #5: *Can you also confirm if the swings at the parks will remain or be removed?*

Response: The swings at the park will remain.

Question #6: *Will the whole area or just the new areas need the EWF?*

Response: The whole area will need the EWF.

Question #7: *Will a total of 4 or 5 copies of the bid need to be submitted?*

Response: Sets of five (5), one (1) original and four (4) copies need to be submitted.

Question #8: *The Veterans park in the bid is the existing one at the Sports complex – or a new area at the Memorial area?*

Response: It is the existing one at the Sports Complex.
