The Special Provision section of the Request for Qualification solicitation and the exhibits is attached herein are made a part of the entire agreement between the parties with respect to the subject matter of the Request for Qualification and Resultant Contract Agreement, and supersede the General Provisions, any prior negotiations, agreements and understanding with respect thereto.

PURPOSE:

The County of Galveston (County) is soliciting sealed Statements of Qualifications from experienced firms for the collection of debts and accounts receivable items as described in the Scope of Service section using the most cost effective methods and highest professional standards. The successful firm will have the responsibility of managing the work as described in the Scope of Service section of this solicitation in accordance with the highest ethical standards of their profession.

In order to be considered, interested firms must submit qualification documents by **2:00 P.M., CST, on 06/05/2014**, to the office of the Galveston County Purchasing Agent, who for the purposes of this solicitation is:

The time stamp clock located in the reception area of the Purchasing Agent's Office will serve as the official time keeping piece with regard to this solicitation. No late qualification packages will be accepted.

All potential proposers are strongly advised to keep responses concise and adhere to the instructions mentioned in this proposal document.

QUESTIONS:

All questions regarding this solicitation must be in writing and received by **2:00 P.M., CST on 06/05/ 2014**, addressed to the Purchasing Agent via e-mail at rufus.crowder@co.galveston.tx.us. All properly submitted questions will receive responses in the form of an addendum and the County will attempt to notify all other potential proposers that have shown an interest in this request for services.

SCOPE OF SERVICE:

Interested firms shall submit documentation illustrating their methodology, experience, and expertise and should describe in detail how the respondent will provide collection services for debts and accounts receivables such as unpaid fines, fees, court costs, forfeited bonds, and restitution ordered by the Justice of the Peace (JP) Courts serving Galveston County as referenced in the resultant agreement.

The successful firm shall be responsible for but not limited to the following actions:

- The sending of collection letters;
- Notifying defendants of their fines and fees by telephone, electronic mail (e-mail), facsimile (fax), or other acceptable electronic methods;
- The act of conversion of data (if necessary) from the county's system to the firm's system as well as the conversion of case data updates from the firm's system to the County's system at no expense to the County;
- The act of extracting the delinquent data from the County's system (monthly/weekly/etc.) at no expense to the County.;

- Sign all letters, requests for payments, legal instruments, pleadings, drafts, authorizations and documents that are reasonably necessary to pursue collection of the County's claims;
- Maintain accurate records of the status of all accounts in the collections process and make such information available on demand to the Galveston County justice courts;

- Update firm records frequently with information from Galveston County justice courts regarding the status of accounts in the collection process, in order to maintain the highest level of accuracy in the collection process;
- Provide written status reports monthly and verbal status reports not less than quarterly to Commissioners' Court on outstanding fines and fees and collections; and
- Be authorized to represent itself and the County should the successful firm and/or the County become a defendant in a suit filed by a defendant arising from the firm's collection efforts; The firm will be required to provide such defense at no additional cost to the County.

Furthermore, the successful firm shall not institute any litigation against any defendant without prior consultation with the County unless superseded by language in the resultant contract.

RESULTANT CONTRACT AND TERM:

Successful firm shall enter into an agreement with the Galveston County Commissioners' Court under the guidelines specified in the Texas Code of Criminal Procedure, Article 103.0031.

The initial term of the resultant agreement shall commence on the date of the Commissioners' Court award and expire two (2) years after unless otherwise notated in the resultant agreement. The agreement shall be automatically extended for an additional two (2) year period unless the County or successful firm notifies the other in writing that it does not wish to continue the agreement beyond the stated term.

BONDING:

The firm will be required, prior to commencing efforts to provide the requested services, to post a bond, made payable to the County of Galveston, in the amount of \$100,000 conditioned upon the firm's proper accounting and remittance of court costs and expenses the firm collects under the debts and accounts receivable collection contract. Alternatively, the firm may provide an irrevocable letter of credit enabling the County to withdraw funds from a bank in the name of the firm for the named services and expenses. The term of the bond or the letter of credit shall correspond with the term of the associated collection contract and shall be on terms and conditions acceptable to the Galveston County Commissioners' Court.

ADDITIONAL SERVICES:

The County may, from time to time, specify in writing, additional actions that should be taken by the successful firm in the collection of fines and fees that may not be subject to the resultant agreement. No additional fees will be paid for such actions with the exception of litigation.

QUALIFICATIONS AND INFORMATION REQUESTS:

All interested firms must provide, at a minimum, the information requested below:

- Documentation firms' capability, credentials, skill set, and capacity to perform the requested services as requested in the Scope of Work. Include the number of employees assigned to this effort and the number of employees within the firm;
- Indicate the firms' workload excluding this effort;

- Listing of current and past collection contracts with other Texas governmental entities including size, scope, complexity, and actual services provided;
- Level of experience including years in business and years conducting similar collection services;
- Additional documentation supporting experience, qualifications, and financial stability of the firm;
- Resumes detailing the experience and qualifications of key personnel to be assigned to the project team;
- Define service commitment of key personnel assigned to the project team;
- Description of the methodologies of collections and reporting used in jurisdictions similar to Galveston County;
- Description of the objective results of collection efforts by the firm in jurisdictions similar to Galveston County;
- Description of the frequency and type of reporting provided to clients in jurisdictions similar to Galveston County, including reporting on outstanding fines and fees, status of collections on accounts, and performance on collections accounts overall;
- Define the firm's approach or plan (methodology) to provide the requested collection services, and how that plan is particularly suited to Galveston County's needs;
- Certificate of insurance indicating coverage in the amounts stated in the General Provisions, page 9, item 35. In lieu of submitting a certificate of insurance, respondents may submit, with bid, a notarized statement from an Insurance company, authorized to conduct business in the State of Texas, and acceptable to Galveston County, guaranteeing the issuance of an insurance policy, with the coverage stated, to the Respondent named therein, if successful, upon award of the resultant contract.

RESPONSE FORMAT:

The County requires that all responses be submitted in the following format. One (1) original paper submission and one (1) electronic response on CD. CD must contain only one (1) file in PDF format and must match written response identically. Failure to provide proper CD is cause for disqualification. Statement of Qualifications must take the form of a bound 8-1/2-inch by 11-inch report with a Table of Contents and all pages numbered in sequence (**maximum 25 pages**). Binding must allow reports to lay flat when open and may be either wire or GBC. Format of the report may be either "portrait" or "landscape" format with binding on either long or short side. Responses are to be in the following order and must detail requirement as outlined above:

- Cover letter;
- Table of Contents;
- Detailed statement assuring firm fully understands scope of work;
- Detailed qualifications of the firm as requested in the Qualifications and Information Requests section of this solicitation.

SELECTION PROCESS:

The Galveston County Commissioners' Court intends to award a debts and collection services (fines and fees) contract to the qualified firm that best demonstrates the commitment and application of experience, resources, and methods to the objectives established by Galveston County. A copy of a draft Fines and Fees collection contract is attached to this RFQ. It is the intention of the County to use this draft contract as a starting template for the resultant contract awarded to the firm. The terms of the contract will be negotiated.

Written responses to this RFQ will be used to evaluate each firm' qualifications, proposed team members, and the suitability of indicated approaches or plans for the requested service. A short list of firms may be selected for possible oral interviews. Representatives of Galveston County, integrally involved in the process, will conduct both the initial screening and the oral interviews.

The Purchasing Agent shall review the submitted Statements of Qualification and may select a short list of firms to interview for clarification purposes if needed. Qualified statements will be presented to the Commissioners' Court for consideration of award. Respondents not selected for further consideration may be notified at the first opportunity.

At each stage of the process, the County will consider any number of individual factors weighing on each firm's qualifications. These considerations will include but are not limited to:

% Points Evaluation Criteria

- 20% Ability to perform the Scope of Work and requested services, (basic and additional);
- 20% The experience and capabilities of the firms and key personnel assigned to the project team with clients of similar scale and needs with specific emphasis on governmental experience;
- 10% The firm's ability to maintain accurate records, consistent between the justice courts and the firm, of accounts subject to collection;
- 15% The firm's record of maximizing collections in jurisdictions similar to Galveston County;
- 15% The frequency and type of reporting provided to clients in jurisdictions similar to Galveston County;
- 15% How well the approach or plan (methodology) is particularly suited to Galveston County's specific needs;
- 5% Financial stability and general reliability of the firm.

BEST AND FINAL OFFERS (BAFO)

If invoked, interviews with selected short listed firms will be held in the Galveston County Purchasing Department, Bid Conference Room, located at the Galveston County Courthouse, 722 Moody Avenue (21st Street), Fifth (5th) Floor, Purchasing, Galveston, Texas 77550, at which time the selected firms will be asked to present their qualification statements and introduce their prime team members. Selected firms will be notified in advance of interview times.

Question #5 *Please provide the number of accounts and dollar value that has been placed with your current vendor over the past 3 years?*

Response: These numbers are estimates based on information received from the current vendor. The numbers are estimates as a result of coding errors by the Clerk. Additionally, one of our largest JP Courts has not submitted to collections since 2008. A substantial backlog in that court will be cleaned for added to collections.

Response: The County's vendor has been under contract since April 23, 2008.

Question #11 *What are the County's effective collection rates (dollars & percentages) since start of the contract with current vendor? What are the annual numbers broken down by calendar year?*

Response: These numbers are estimates based on information received from the current vendor. The numbers are estimates as a result of coding errors by the Clerk. Additionally, one of our largest JP Courts has not submitted to collections since 2008. A substantial backlog in that court will be cleaned for added to collections.

Question #12 *What information is available about the existing Court portfolios – the number of cases and dollar amounts outstanding, along with a breakdown by age and dollar amount?*

Response: Any information contained in the case management system can be extracted with report writer queries. Our I.T. department can generate these reports, but would need sufficient time to do so.

Question #13 *Do the Courts take partial payments or only payment in full on delinquent cases?*

Response: The courts do accept partial payments, but require a written payment agreement. However, partial payments received via online credit card payment in cases without a written payment agreement on file are not returned.

Question #14 Will the Courts submit both adjudicated and un-adjudicated cases (+60 days) for collections as it pertains under Art.103.0031, Texas Code of Criminal Procedure?

Response: Yes, we submit both adjudicated and un-adjudicated cases for collections.

Question #15 For credit card payments, who is the County's credit card merchant? What payment options do they provide for the Courts?

Response: Official Payments is the credit card merchant for court collections.

Question #16 What were the attorney/collection fee amounts paid to the current vendor in years 2012 and 2013?

Response: Due to system reporting limitations, an estimate of amounts paid during this period is \$297,837.43

Question #17 What is the process by which cases are referred to the current collection vendor?

Response: Currently, the JP Clerk codes the account for collections and, on a regular schedule, triggers the creation of the electronic file for collections. However, the new contract would require the collections vendor to trigger the creation of the electronic file from our case management system. Coding will still be handled by the Clerk.

Question #18 Who codes and uncodes accounts turned over to the collection vendor that are partially or fully paid?

Response: The Clerk handles coding.

Question #19 Addendum #1 issued May 27 states that the Special Note at the top of the Special Provisions was omitted from the original RFQ. The Special Note states, in part, that the Special Provision section supersedes the General Provisions. Does that mean the Procurement Card acceptance on page 3, #11, does not apply to this RFQ?

Response: No, only if the Special Provisions make mention of the item.

Question #20 The response format on Page 3, Special Provisions, of the RFQ states that the Statement of Qualifications must be numbered in sequence with a maximum of 25 pages. The 4th bullet below that statement is: Detailed qualifications of the firm as requested in the Qualifications and Information Requests section of this solicitation. Is this 4th bullet item the Statement that has a 25-page maximum? Is the cover letter, detailed statement assuming firm fully understands scope of work, the Galveston County required forms and contracts, the Firm's proposed contract and any Appendix items outside of the 25-page maximum?

Response: Yes for both questions.
