The following information is being provided to aid in the preparation of your proposal submittal(s)

Question #1: *The Proposal Forms include a request for three “references who can attest to the Proposer’s capability to carry out the requirements set forth in this bid” (page 2 of the forms) as well as a request for three “References of major supplier of Proposer who can speak to the financial capability of the Proposer to carry out the requirements set forth in this bid” (page 3 of the forms). Please clarify whether you are seeking three or six references and, if so, exactly what is being requested on page 3 of this form. Since, as a consulting firm, we do not deal in products or materials from third-party suppliers, does this requirement apply to this solicitation?*

Response: The requirement of a request for three “references who can attest to the Proposer’s capability to carry out the requirements set forth in this bid” (page 2 of the forms) are to be complied with. Proposers are to disregard the request for three “References of major supplier of Proposer who can speak to the financial capability of the Proposer to carry out the requirements set forth in this bid” (page 3 of the forms).

Question #2: *Please clarify exactly what consulting services should be included in our proposed fee—is the final deliverable the requirements and specifications for a replacement CAD/Mobile/RMS/JMS Solution for Galveston County agencies? Or, do you want proposers to also include consulting services for vendor evaluations, contract negotiations support, and implementation oversight?*

Response: Services are just for requirements and specifications for a replacement CAD/Mobile/RMS/JMS Solution.

Question #3: *Are the current solutions listed in the Scope of Work single vendor or multiple disparate vendors? Are they integrated?*

Response: There are multiple vendors with some integration already in place.

Question #4: *How old are the systems in scope?*

Response: The two largest are OneSolution Financials 1998 and OSSI 2004.

Question #5: *How many and what specific agencies interact with these systems?*

Response: VFD -Volunteer Fire Department, FD - Fire Department, PD – Police Department, EMS - Emergency Management Services

Response: We intend to engage this service shortly after the RFP is awarded.

Question #8: *Are project activities expected to be concluded on-site, remotely, or using a hybrid model?*

Response: A hybrid model will most likely be the best approach.

Question #9: *Has this project been funded? If so, would the County be willing to share its budget?*

Response: No specific budget has been set.
