NOTICE OF PUBLIC HEARING ON TAX INCREASE

A tax rate of \$0.472668 per \$100 valuation has been proposed by the governing body of the Village of Tiki Island.

PROPOSED TAX RATE \$0.472668 per \$100 NO-NEW-REVENUE TAX RATE \$0.247110 per \$100 VOTER-APPROVAL TAX RATE \$0.555472 per \$100

The no-new-revenue tax rate is the tax rate for the 2022 tax year that will raise the same amount of property tax revenue for the Village of Tiki Island from the same properties in both the 2021 tax year and the 2022 tax year. The voter-approval rate is the highest tax rate that the Village of Tiki Island may adopt without holding an election to seek voter approval of the rate.

The proposed tax rate is greater than the no-new-revenue tax rate. This means that the Village of Tiki Island is proposing to increase property taxes for the 2022 tax year.

A public hearing on the proposed tax rate will be held on September 20, 2022 at 6:00 pm at 747 Tiki Drive, Tiki Island, Texas 77554.

The proposed tax rate is not greater than the voter-approval tax rate. As a result, the Village of Tiki Island is not required to hold an election at which voters may accept or reject the proposed tax rate. However, you may express your support for or opposition to the proposed tax rate by contacting the members of the Village of Tiki Island Board of Aldermen of the Village of Tiki Island at their offices or by attending the public hearing mentioned above.
