Response: The estimated value of construction is \$100,000 to \$200,000.

Question #3: *Is there an anticipated start date and anticipated completion date for the work to be done?*

Response: Contract period item 33 of the Special Provisions for Construction is 365 days after notice to proceed. However, per Contract award it is 65 days. Under normal circumstances, 65 days should be adequate however, given the materials shortage issues, I would recommend the duration be increased to at least 90 days.
