

**ORDER CALLING SCHOOL  
BOARD TRUSTEE ELECTION BY PLURALITY VOTE**

THE STATE OF TEXAS §  
COUNTIES OF GALVESTON AND HARRIS §  
CLEAR CREEK INDEPENDENT SCHOOL DISTRICT §

WHEREAS, the Board of Trustees deems it necessary to call the trustee election hereinafter described pursuant to the provisions of the Texas Education Code, Section 11.052 and 11.060, and the Federal Voting Rights Act of 1965, as amended;

THEREFORE, BE IT ORDERED AND RESOLVED BY THE BOARD OF TRUSTEES OF THE CLEAR CREEK INDEPENDENT SCHOOL DISTRICT THAT:

Section 1. An election for school board trustees for Single-Member District 2, and Single-Member District 3 shall be held in the Clear Creek Independent School District (“School District”) on the 6th day of May, 2023. All registered voters of the School District residing in Single-Member District 2 (Exhibit A) shall be entitled to vote for one candidate in Single-Member District 2; all registered voters of the School District residing in Single-Member District 3 (Exhibit A) shall be entitled to vote for one candidate in Single-Member District 3. The deadline to file for a place on the ballot is February 17, 2023.

The hours during which the polling places shall be open for voting on May 6, 2023 shall be from 7:00 a.m. to 7:00 p.m., at polling places to be designated by Galveston County and Harris County. The Harris County and Galveston County Main Early Voting Offices are as follows:

Section 2. Galveston County Early Voting shall be conducted by early appearance and by mail. The period for early voting by personal appearance for the election shall be April 24 through May 2, 2023, as indicated below:

April 24 - 28 (Monday – Friday)	8:00 a.m. to 5:00 p.m.
May 1 – 2 (Monday – Tuesday)	7:00 a.m. to 7:00 p.m.

Harris County Early Voting shall be conducted by early appearance and by mail. The period for early voting by personal appearance for the election shall be April 24 through May 2, 2023, as indicated below:

April 24 – 29 (Monday – Saturday)	7:00 a.m. – 7:00 p.m.
April 30 (Sunday)	12:00 p.m. – 7:00 p.m.
May 1 – 2 (Monday – Tuesday)	7:00 a.m. – 7:00 p.m.

Section 3. If an application for ballot by mail is sent by fax or email to Harris County or Galveston County, the original still must be mailed to the mailing address(es) above by the fourth business day. All Election Day and Early Voting polling locations are subject to change by Harris County and Galveston County. A complete list of Galveston County early voting and election day voting locations can be found online at galvestonvotes.org and a complete list of

Harris County early voting and election day voting locations can be found online at harrisvotes.com.

Section 4. Notice of such Election shall be posted and published by Clear Creek ISD as required by law.

Section 5. Testing of the automatic tabulation equipment will be performed and notice thereof will be given by Galveston County and Harris County in accordance with subchapter D of Chapter 127 of the Texas Election Code.

Section 6. The Superintendent or designee is hereby authorized to negotiate and execute all agreements with Galveston County and Harris County, or any other governmental entity as appropriate, and provide all notices necessary to conduct a joint election and administer election services for the trustee election on May 6, 2023.

Section 7. If any portion of this Order is held invalid by a court of competent jurisdiction, the remaining provisions of this Order shall remain in full force and effect.

Section 8. Election of trustees for each office shall be by plurality vote (Texas Education Code, Sec. 11.057); and the results of said Election of May 6, 2023, shall be canvassed by the Board of Trustees of the School District not earlier than the third day (but only if provisional ballots and ballots mailed from outside the United States have been counted) and no later than the eleventh day after election day.

Section 9. This Election Order is effective immediately upon its passage and approval.
