The early voting clerk, in accordance with the provisions of the Texas Election Code, shall maintain a roster listing each person to whom an early voting ballot to be voted by mail is sent. The roster shall be maintained in a form approved by the Secretary of State.

SECTION FIVE:

Said election shall be held in accordance with the Constitution and laws of the State of Texas, and all duly qualified resident electors of the Village of Tiki Island, Texas, shall be entitled to vote.

SECTION SIX:

In accordance with the Joint Election Agreement, the Galveston County Election Division is hereby authorized and directed to furnish all necessary election supplies to conduct such election.

SECTION SEVEN:

The order in which the name of the candidates are to be printed on the ballot in the

general election shall be determined by a drawing by the City Secretary, as provided by Section 52.094 of the Texas Election Code. The City Secretary shall post a notice in her office, at least seventy-two (72) hours prior to the date on which the drawing is to be held, of the time and place of the drawing, and shall also give personal notice to any candidate who makes written request for such notice and furnishes to the City Secretary a self-addressed, stamped envelope. Each candidate involved in the drawing, or a designated representative, shall have a right to be present and observe the drawing.

SECTION EIGHT:

The candidates receiving a majority of votes in each of the positions to be filed at such election shall be declared elected.

SECTION NINE:

The voting at such election shall be by electronic ballot system. Early voting by personal appearance at such election shall be by electronic ballot system; early voting by methods other than by personal appearance shall be by paper ballot.

SECTION TEN:

Notice of this election shall be given in accordance with the provisions of the Texas Election Code and returns of such notice shall be made as provided for in said Code. The Mayor shall issue all necessary orders and writs for such election, and returns of such election shall be made to the City Secretary immediately after the closing of the Polls.

SECTION ELEVEN:

Said election shall be held in accordance with the Texas Election Code and the Federal Voting Rights Act of 1965, as amended.
