WELCOME

OVERVIEW

Galveston County parks are host to more than a half-million residents and visitors each year and home to a wealth of wildlife. Within the Galveston County parks system there is approximately 1,500 wonderful acres of recreational parkland. There are currently 20 parks, 10 public boat ramps, and an impressive assortment of indoor and outdoor rental facilities that are easily accessible and expertly managed and maintained.

OBJECTIVES

Bathrooms are cleaned frequently and trash pulled

Pavilions are empty & blown out before permit holder arrivals

Reservation signs are flipped accordingly

Outdoor and indoor power outlets are functional

Inspect facilities monthly, and vehicles weekly

FDRs are completed timely and eligibly for indoor rentals

STEPS TO EXCE

KEY POINT 1

Always take at least 5 minutes to thoroughly check your mastersheets and create a plan to ensure your events are covered.

KEY POINT 2

Before the permit holder arrives, check and inspect the facility to make sure kitchen appliances, wall outlets, restrooms, a/c etc. are all working properly.

KEY POINT 3

When working indoor events, you must give permit holders a quick tour of the building so they know where everything is at.



STEPS TO EXCE

KEY POINT 4

When not busy with permit holders, you should be making rounds throughout the parks and boat ramps picking up and disposing trash bags in dumpsters.

KEY POINT 5

After indoor events are over, ensure they cleaned up properly by quickly inspecting the facility before they leave. Check walls for nails, tape, or staples that got left behind.

KEY POINT 6

Permit holders are scheduled for the time frame either on your mastersheet or board, they should not be given "free" time to decorate or clean up.


