The following information is being provided to aid in the preparation of your RFP submittal(s):

Question #1: What is the level of public involvement that you are envisioning for this?

Response: Public involvement will include preparing and implementing a stakeholder and community

engagement plan, facilitating meetings with stakeholders, and documenting community input.

Question #2: Do you accept electronic signatures as "original signatures?

Response: Yes, as supported by the law that governs this area, however, original "wet" signatures are

preferred.

Question #3: Are there any further requirements for the corporate profile and/or the project approach (Tabs

2 and 3) mentioned in the RFQ, aside from the 15-page limit?

Response: Delete the first bullet point under paragraph K "The combined number of pages between corporate

profile and project approach (Tabs 2 and 3) shall not exceed fifteen (15). Respondent may choose any

internal breakdown for the 15-page limitation.

Question #4: Is "Category 1: A brief narrative..." from the evaluation criteria part of Tab 3, Approach

section? If so, does this mean that Tb 3 has a 6-page limit?

Response: The tabbed sections should follow the four scoring categories found on page 101. Scoring

Category 1 is a brief narrative and limited to six pages. Scoring Category 3 does not have a page

limitation.

Question #5:

Can you clarify the organizational structure for the response, as described on page 98 of the RFQ in the following statement: "The responses are to be provided within a three-ring binder, include an accurate table of contents, and be organized/tabbed in the sections described below"? We could not find any follow up information on this.

Response:

The tabbed sections should follow the four scoring categories found on page 101.
