To All Prospective Proposers:

The following information is being provided to aid in preparation of your proposal submittal(s):

Question #1: *We need a copy of the bid specifications and drawings in order to participate. The Bid Packet as downloaded from the Galveston Co. Solicitations & Bids sit references on page 120 – 127 several specification sections but these are not included in the Bid Package as downloadable. How do we obtain a full set of specifications and drawings?*

Response: Due to security issues involving this jail project, interested parties will have to **qualify** as responsible vendors by submitting what is requested per the stated instructions of **1.5., QUALITY ASSURANCE, Item B, Security Electronics Contractor Approval, pages 121-124 of the pdf**. Qualified vendors will be notified and either sent specifications and plans or allowed access to their location for retrieval.

Question #2: *We believe this RFP is asking for pre-qualification information only and if shortlisted then drawings/specifications will be issued to us?*

Response: See response to Question #1.

Question #3: *We assume your deadline of May 23rd is the deadline for the pre-qualification information and not the bid of the project including dollar amount, bid forms, bid bonds, etc.?*

Response: That is correct. May 23rd is the deadline for the **pre-qualification documents/information only** so that plans and specifications can be released.

Question #4: *The documents listed ATTACHMENTS (Non-Collusion, Boy Cot of Israel, Bid Bond, etc.) are shown for references of what the bid documents will consist of and do not need to be turned in with this initial RFP?*
