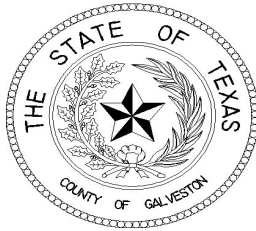

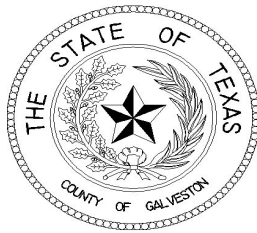

The Galveston County Auditor's Office has examined the collections of the Juvenile Justice Department for the months of April 2024 through June 2024.
