A tax rate of \$0.246097 per \$100 valuation has been proposed by the governing body of the City of Santa Fe.

The no-new-revenue tax rate is the tax rate for the 2024 tax year that will raise the same amount of property tax revenue for the City of Santa Fe from the same properties in both the 2023 tax year and the 2024 tax year. The voter-approval rate is the highest tax rate that the City of Santa Fe may adopt without holding an election to seek voter approval of the rate.

The proposed tax rate is greater than the no-new-revenue tax rate. This means that the City of Santa Fe is proposing to increase property taxes for the 2024 tax year.

A PUBLIC HEARING ON THE PROPOSED TAX RATE WILL BE HELD ON September 12, 2024 AT 7:00 PM AT Santa Fe City Hall, Council Chambers, 12002 Highway 6, Santa Fe, Texas 77510.

The proposed tax rate is not greater than the voter-approval tax rate. As a result, City of Santa Fe is not required to hold an election at which voters may accept or reject the proposed tax rate. However, you may express your support for or opposition to the proposed tax rate by contacting the members of the City Council of City of Santa Fe at their offices or by attending the public hearing mentioned above.
