A tax rate of \$0.415276 per \$100 valuation has been proposed by the governing body of Village of Tiki Island.

The no-new-revenue tax rate is the tax rate for the 2024 tax year that will raise the same amount of property tax revenue for Village of Tiki Island from the same properties in both the 2023 tax year and the 2024 tax year. The voter-approval rate is the highest tax rate that Village of Tiki Island may adopt without holding an election to seek voter approval of the rate.

The proposed tax rate is not greater than the no-new-revenue tax rate. This means that Village of Tiki Island is not proposing to increase property taxes for the 2024 tax year.

A PUBLIC MEETING TO VOTE ON THE PROPOSED TAX RATE WILL BE HELD ON September 17, 2024 AT 6:00 PM AT Public Safety Building, 747 Tiki Drive, Tiki Island, Texas 77554.

The proposed tax rate is also not greater than the voter-approval tax rate. As a result, Village of Tiki Island is not required to hold an election to seek voter approval of the rate. However, you may express your support for or opposition to the proposed tax rate by contacting the members of the Board of Aldermen of Village of Tiki Island at their offices or by attending the public meeting mentioned above.
