A tax rate of \$0.023932 per \$100 valuation has been proposed by the governing body of the Galveston County Navigation District No 1.

The no-new-revenue tax rate is the tax rate for the 2024 tax year that will raise the same amount of property tax revenue for the Galveston County Navigation District No 1 from the same properties in both the 2023 tax year and the 2024 tax year. The voter-approval rate is the highest tax rate that the Galveston County Navigation District No 1 may adopt without holding an election to seek voter approval of the rate.

The proposed tax rate is not greater than the no-new-revenue tax rate. This means that the Galveston County Navigation District No 1 is not proposing to increase property taxes for the 2024 tax year.

A PUBLIC MEETING TO VOTE ON THE PROPOSED TAX RATE WILL BE HELD ON August 20, 2024 AT 3:30 PM AT 6615 Stewart Road, Suite 101, Galveston, Texas 77551.

The proposed tax rate is also not greater than the voter-approval tax rate. As a result, the Galveston County Navigation District No 1 is not required to hold an election to seek voter approval of the rate. However, you may express your support for or opposition to the proposed tax rate by contacting the members of the Board of Directors of the Galveston County Navigation District No 1 at their offices or by attending the public meeting mentioned above.
