Investment Report – FY 2023 Re:

On September 30, 2023, total invested funds of Galveston County had a market value of \$142,316,914. As required by Galveston County's Investment Policy and in accordance with Government Code 2256, all investments were made with the following objectives in order of priority. First, the safety of the principal and maintenance of adequate liquidity were given the highest consideration. Second, diversification was accomplished by investing county funds into two separate PFIA investment pools (Texas Class and Texas RANGE), as well as by purchasing Certificates of Deposit.

The weighted average maturity (WAM) for investments was 21 days, and weighted yield to maturity (YTM) was 3.45%.

The interest earned for all investments during the fiscal year 2023 totaled \$6,901,541 compared to \$1,749,531 for fiscal year 2022. This is an increase year-over-year of \$5,152,010 and is equivalent to 1.3 cents on the FY 23 tax rate.

Attached is the Galveston County FY 2023 Annual Investment Report which consists of Summary Statement of Investment Position, Transaction Details, and Schedules of Investments by Fund, together with graphs and charts providing a visual reference for investments.

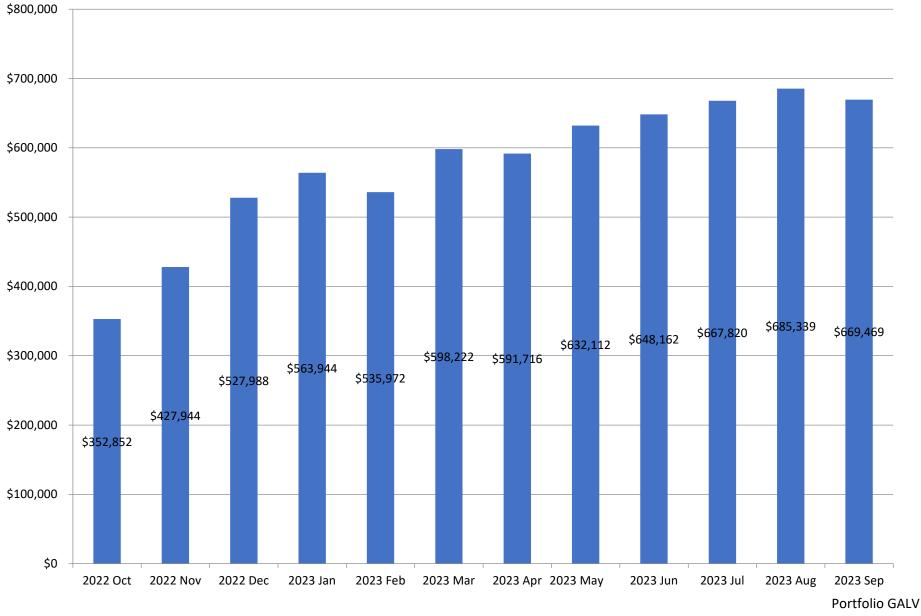
# Book Value by Investment Type
