Re: Justice of the Peace, Precinct 3 Cash Count and Statistical Analysis

Cash Count

The auditor conducted a surprise cash count at the Galveston office on July 24, 2018, at the La Marque office on July 30, 2018 and at the Crystal Beach office on August 2, 2018. All collections were accounted for at the time of the surprise cash counts. Controls are in place to ensure the staff uses a lockable safe to secure collections until ready to be deposited. The safe remains locked when not in use.

Statistical Analysis

A statistical analysis was performed on the cases filed through JP3 during FY2016, FY2017 and FY2018 (through June 2018). The data for the analysis was obtained from the Odyssey Case Index Report. The following reflects the number and types of cases filed during each fiscal year:
