2013 Allegation of sexual harassment resulted from staff reportedly making fun of information disclosed by a resident regarding behavior the resident engaged in while in the community before being assigned to the facility. Findings of investigation substantiated staff sexual harassment resulting in the suspension without pay of the employee pursuant to progressive discipline on May 10, 2013. Employee subsequently resigned from employment with the department effective June 30, 2013.

2014 Allegation of staff misconduct resulted from a resident complaint related to routine pat search. Investigation, including review of video, revealed no staff misconduct related to this search. Administrative Investigations Division for the State of Texas directed GCJJD to handle as a grievance.
