The following information is being provided to aid in preparation of your bid submittal(s):

Question #1: Can you provide the current pay for the FSD and Cooks?

Response: FSD (1) - \$21 per hour; Cooks (2) - \$12 per hour

Question #2: Do you plan on charging the contractor for the use of utilities (gas, water, electricity)?

Response: No.

Question #3: What is the current number of children being fed on a daily bases?

Response: Detention – 13 residents; Residential - 7 residents; JJAEP/Level 4 Day – 8 juveniles ; Total: 28

Question #4: Are staff meals billed to the County?

Response: Yes.

Question #5: How many staff are fed on a daily bases?

Response: Approximately 10

Question #6: Do the staff eat the same menu? If not, can we get a copy of the staff menu?

Response: Yes, staff eat same menu as the children.

Question #7: Confirm that snacks billed separately than the regular meal price?

Response: Yes, snacks are billed separately from the regular meal price.

Question #8: Are their special requirements for snacks by the facility that differ from the SLP?

Response: No

Question #9: Are any religious diets currently being required? If so, what type?

Response: Currently No. However, this may be needed from time to time, but very seldom.

Question #10: If religious Kosher/Halal meals are required will they be billed separately or at regular meal price?

Response: Billed at the regular meal price.

Question #11: Are Holiday meals required? If so, which Holidays require a special meal?

Response: No, not required but welcomed.
