To All Prospective Qualifiers:

Question #1: Is there more information about the intent/purpose of the agreement and scope of work (buildings, utilities, systems, etc.) to be included in the contract?

Response: Galveston County intends to upgrade outdated and obsolete building equipment through a comprehensive utility conservation program. The County anticipates a major reduction in annual utility consumption and associated operational cost through the program. The program will include 38 facilities throughout the County, with upgrades to include but not limited to HVAC, lighting and controls.

Question #2: How does the county distinguish between traditional ESCO delivery and "as a service"?

Response: Galveston County is interested in utilizing an ESCO to identify, design, install, maintain, monitor, and arrange financing to perform a cost-effective utility conservation retrofit. With consideration of less debt for the County, the as-a-service funding model is an option the County would like to consider further.

Question #3: Is there going to be a pre-qualification conference? This would be very helpful since very little information is provided about the project scope.

Response: At this time, there is no schedule set for a pre-qualification conference.

Question #4: The link in the RFQ to the open solicitation site does not show this bid package. Can you clarify?

Response: The link has been corrected and the bid package is available for download within the open solicitations page.
