- Page 3 indicates no bonds are required for this RFP
- Page 20 indicates a proposal guarantee is required unless specified differently in the Special Provisions
- Page 40 is the Special provisions item C a surety bond is not a requirement for this RFP
- Page 73 Exhibit A indicates a bid guarantee is required (please see the first paragraph regarding why bonds may be needed)

Response: No proposal guarantee bond is required with this RFP.

Question #2: Can you send me the link or electronic set of the drawings for the League City and Bacliff

JP Court House?

Question #3: Please provide clarification regarding two of the referenced forms.

- Regarding the Conflict of Interest Form (Form CIQ), on page 18 of the submittal, item 41, it states that the form must be filed with the County Clerk. The form is also required in the submittal. Are we to file this with the clerk prior to the deadline, as well as include it in the submittal?
- Regarding Form 1295, are you requiring this form with the submittal? It is not on the checklist in the Proposal Form. Or is this to be submitted if we are awarded?

Response:

The Conflict of Interest form should be filed with the County Clerk's office prior to the bid opening date and time. A copy of the receipt from the County Clerk can be submitted with your bid submittal.

Form 1295 is not required with bid submittals. The awarded vendor will be required to have Form 1295 submitted prior to contract signage per statute.
