Question #1: Special Provisions, Item N. Scope of Work - Will the hoist motor be replaced? If so, what type will be

provided?

Response: We need the elevators modernized. If that is included as part of your proposal, please replace.

Question #2: Special Provisions, Item N. Scope of Work – Will the existing Governor and tension sheave be

retained?

Response: We need the elevators modernized. If that is included, please replace.

Question #3: Special Provisions, Item N. Scope of Work – Will the hoist ropes and governor rope be retained?

Response: Yes.

Question #4: Special Provisions, Item N. Scope of Work – Will the County install the code required 3,000 GPH

sump pump and connections?

Response: No.

Question #5: Special Provisions, Item N. Scope of Work - Does all electrical wire in the machine room, on the car

and in the Hoistway need to be replaced? If so does all the electrical piping and duct need to be

replaced?

Response: Replace as needed.

Question #6: Special Provisions, Item N. Scope of Work - Will the mainline disconnect switch be retained with the

existing?

Response: Yes.

Question #7: Special Provisions, Item N. Scope of Work – Will the existing 110V car light and fan disconnect be retained?

Response: Replace as needed.

Question #8: Special Provisions, Item N. Scope of Work - Machine room and pit lighting must meet new lighting

requirements. Will the County be replacing these lights and receptacles?

Response: No.

Question #9: Special Provisions, Item N. Scope of Work – Is there any security required for the control system? i.e.

card readers.

Response: No.

Question #10: The Special Provisions section calls for new Hoistway Doors. Are the door frames being retained as

is?

Response: Replace as needed...

Question #11: Special Provisions, Item N. Scope of Work – Will the door tracts, hangers, interlocks, closers, and

gibbs be retained with the addition of new equipment required by code?

Response: Replace as needed...

Question #12: Is the intent of the specifications to receive the information and cost up front on what is required to

meet code and does this cost need to be included in our bid?
