To All Prospective Qualifiers,

The following information is being provided to aid in preparation of your qualification submittal(s):

Question #1: *The County wants an ADA accessible kayak launch. Should we assume that the County wants all facilities (restrooms, fishing cleaning, and pier) to be ADA accessible?*

Response: Yes.

Question #2: *The County wants to obtain a USACE Permit prior to beginning the collection of data or design engineering. Is the County aware that some basic engineering and drawings must be included in the USAC Permit? How should we address this in our proposal?*

Response: Yes. Address as needed to ensure there is an understanding of additional fees required to obtain the permit.

Question #3: *Does the County have existing permits for the boat ramp facility?*

Response: None that we are aware of.

Question #4: *Are the existing pier or bulkhead to be rebuilt?*

Response: No.

Question #5: *Will the County supply us with a boundary survey for the property?*

Response: Attached you will find the GCAD of the boundaries of the property.

Question #6: *Are we allowed to use 11x17 pages and will they count as 2 pages towards the 15-page limit?*

Response: Yes, you are allowed to use 11x17 pages. Yes they will count as 2 pages.

Question #7: *The second page of the “Qualification Form” appears to pertain to a construction contractor’s financial capability. If it is your intent to relate this to engineering service providers, would you prefer references from past sub-consultants rather than suppliers of materials?*
