We have reviewed the Apparent Low Bidder's bid and have also documented our discussions with several references. After a thorough review, we recommend award for the replacement of the Birch Road Bridge Project to Wade Con, LLC for the sum of \$860,837.00.

The Apparent Low Bidder's bid is 11% below the engineers estimate. Please note there were a few small math errors in some of the other bids however, these errors did not change the order of the bids received.
