Bids were publicly opened and read at 2:00 pm on Thursday, September 17, 2020 for the above-referenced project. The following is a summary of our bid evaluation.

Bid Tabulation - A copy of the Bid Tabulation is attached. A summary of the total amount for each of the submitted bids is as follows.

The T.R. Grace Co., Inc. (dba Houston Elite Risk Management Group) did not include bid prices on Alternate Bid Items 1-8, thus submitting an incomplete bid. This resulted in the T.R. Grace Co., Inc. bid being deemed non-responsive and not considered in the bid tabulation.

The following mathematical errors were identified and corrected on the Bid Tabulation. The errors do not change the apparent low bidder:

- The RAC Industries, LLC Bid Documents contain the following inaccuracies: The Subtotal for Add Alternate Bid Items A1 A8 is listed as \$145,319.80, whereas the correct total is \$146,119.80; the Total Amount Bid including Alternates A1-A8 is listed as \$557,441.60, whereas the correct total is \$558,241.60.
- The Tandem Services, LLC Bid Documents contain the following inaccuracies: The Unit Price for Bid Item No. 12 was entered but the total dollar amount was left blank. This did not change the Total Bid Amount.
- The Aranda Industries, LLC Bid Documents contain the following inaccuracies: The Extra Work Bid Items Total is listed as \$9,150.00, whereas the correct amount is



\$9,275.00; the Subtotal for Add Alternate Bid Items A1 - A8 is listed as \$145,319.80, whereas the correct total is \$146,119.80; the Total Amount Bid is listed as \$554,148.00, whereas the correct amount is \$554,273.00; the Total Amount Bid including Alternates A1-A8 is listed as \$744,009.00, whereas the correct total is \$744,134.00.

Binkley & Barfield, Inc. recommends that Galveston County award the 10th Street Reconstruction Project to RAC Industries, LLC for the amount of Five Hundred Fifty-Eight Thousand Two Hundred Forty-One Dollars and Sixty Cents (\$558,241.60).
